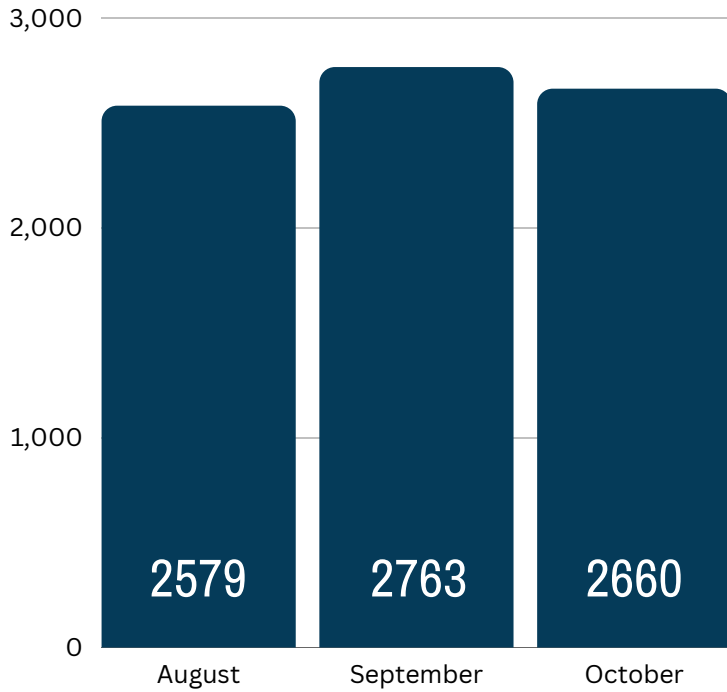

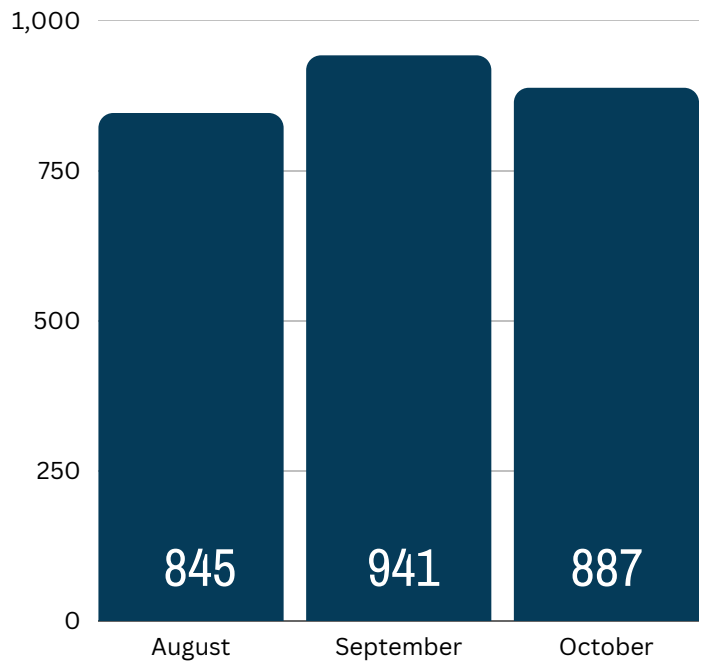

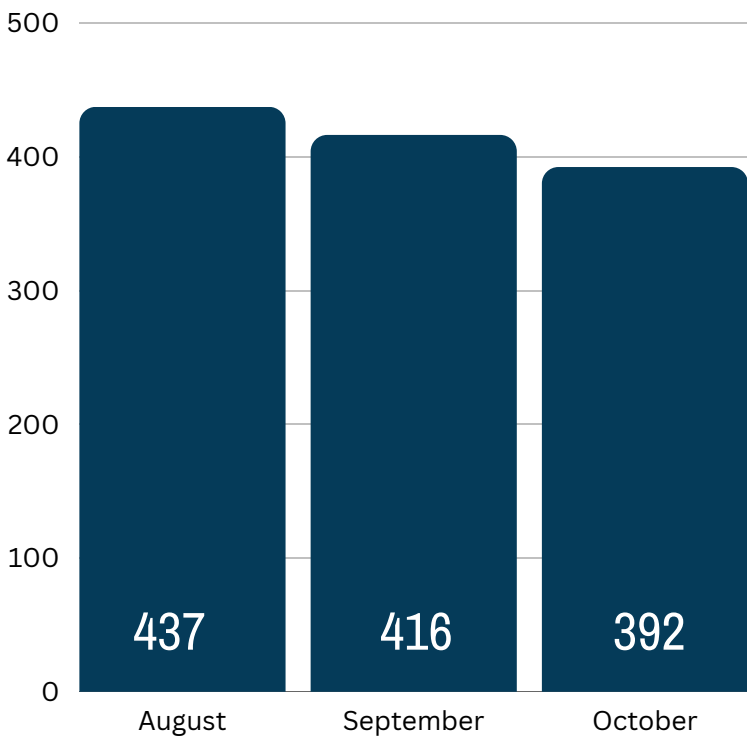
Incidents by Month

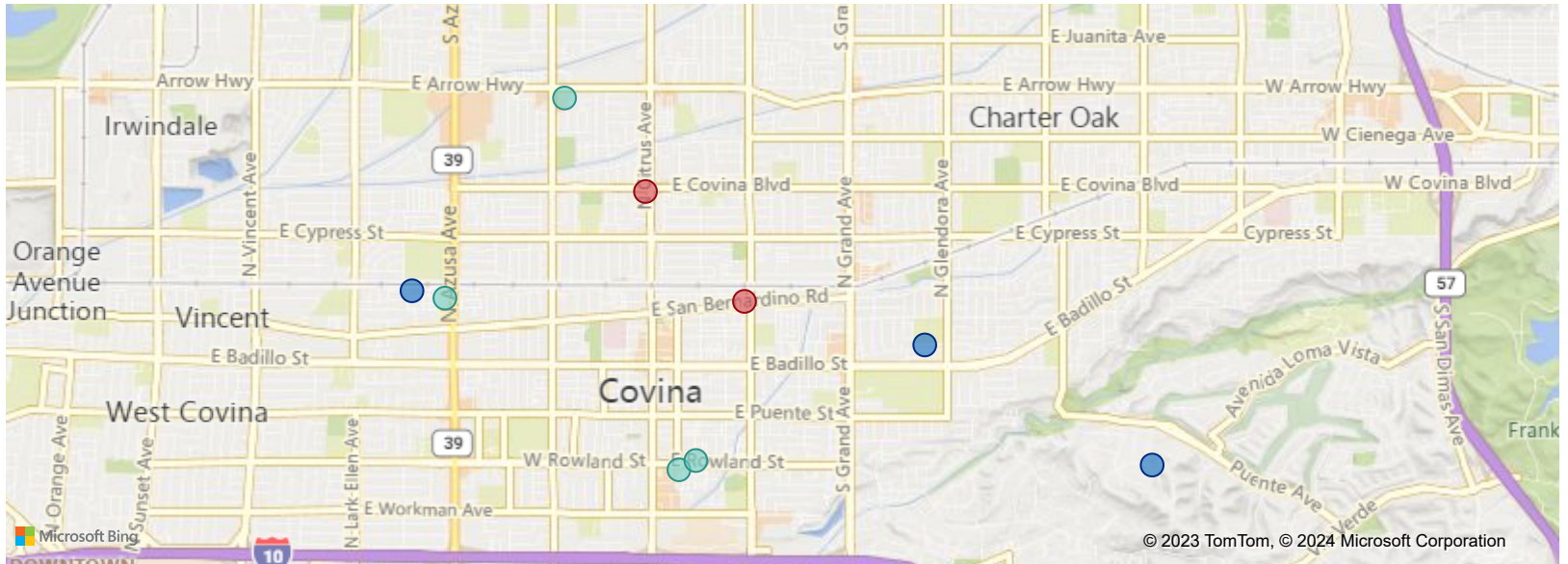


Reports Taken by Month

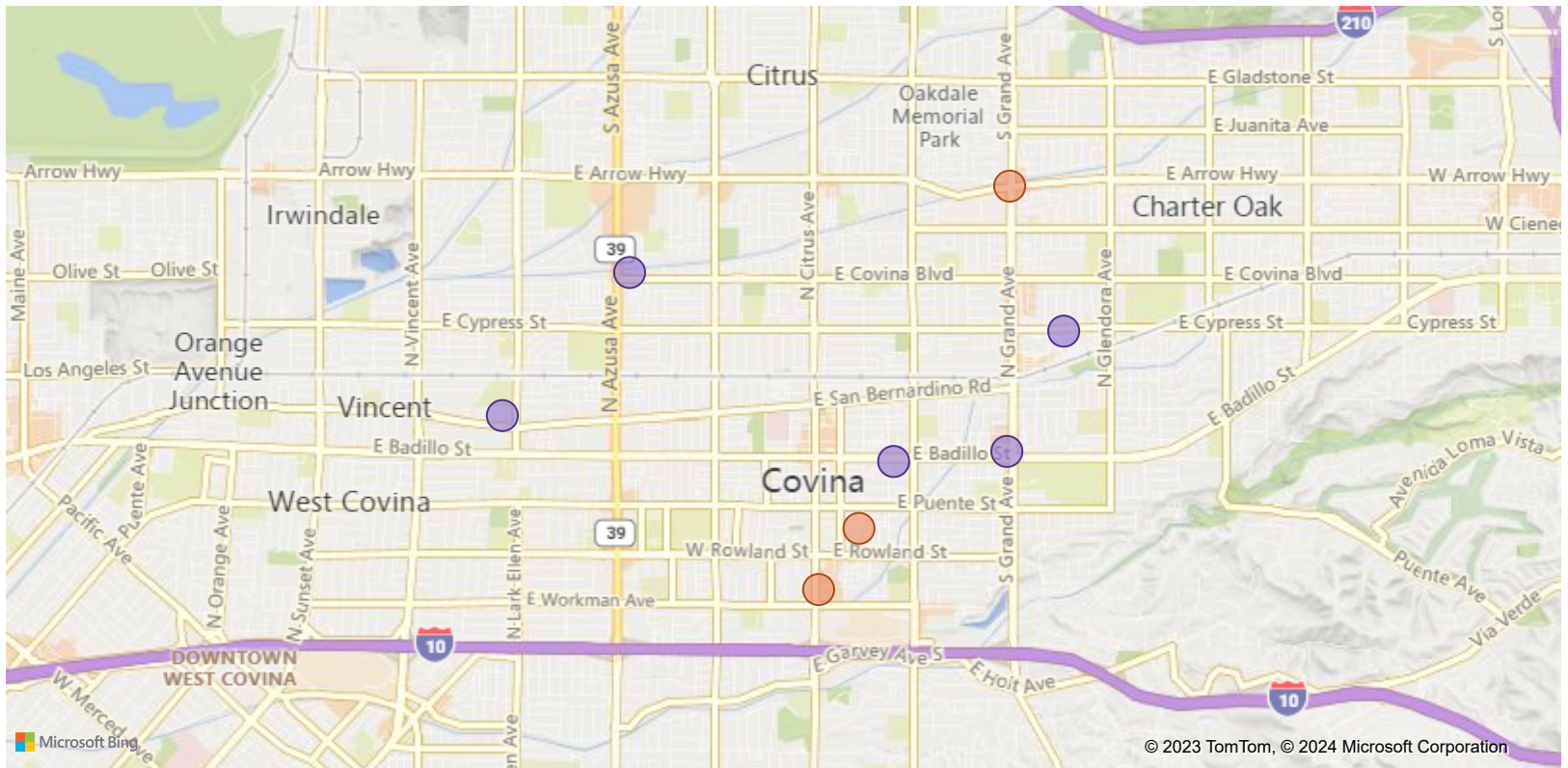

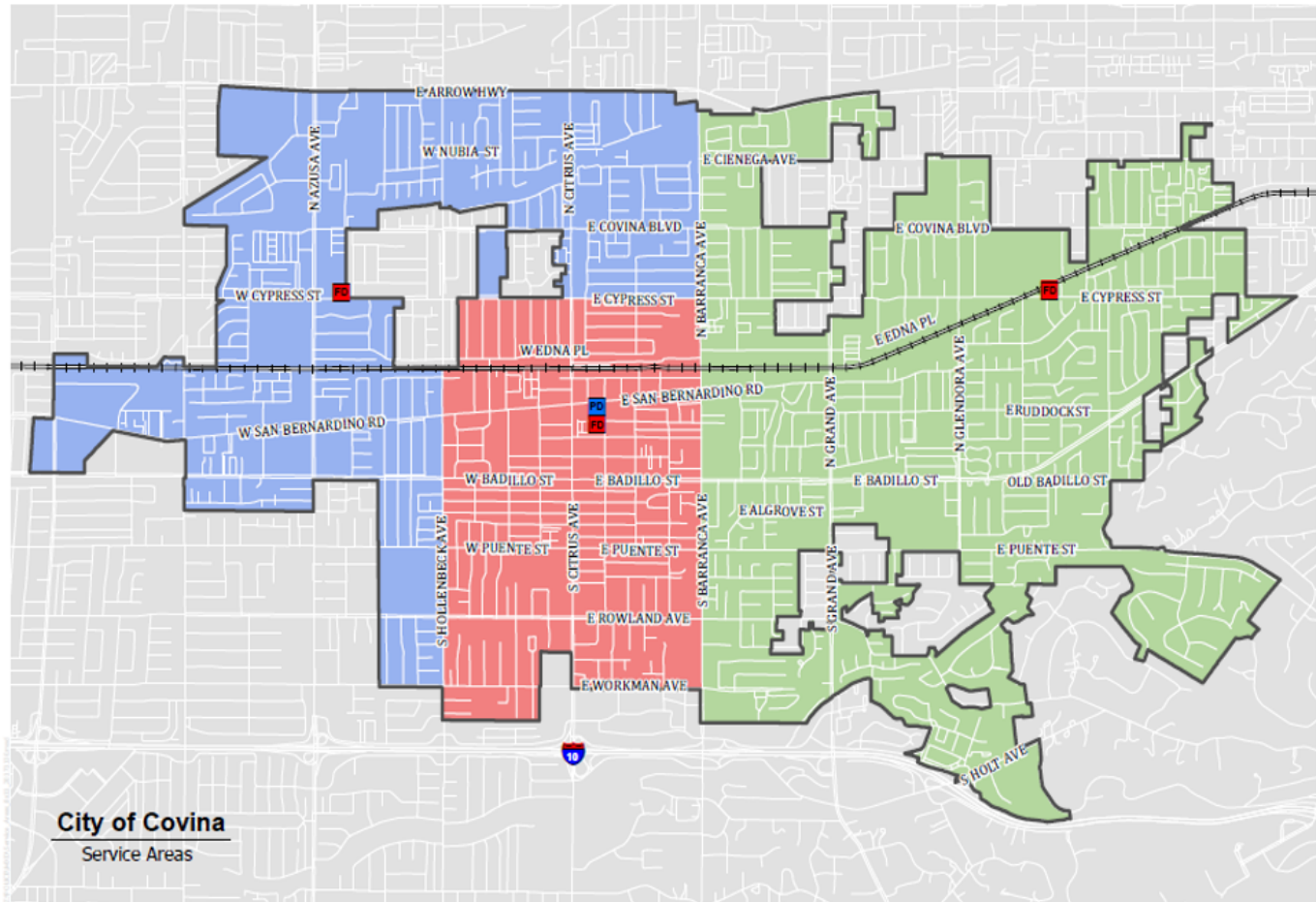

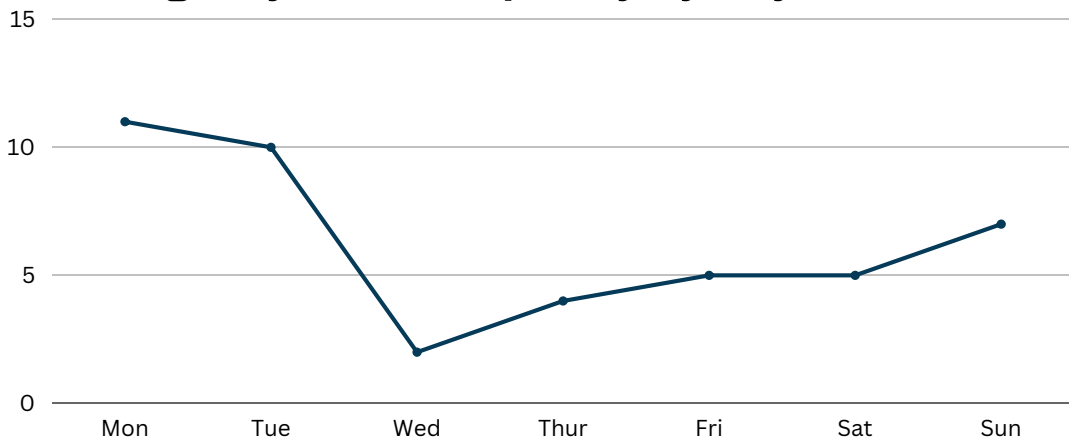
